08. Financial Matters

08.1 Treasurer's Report (Interim Treasurer)

The treasurer gave a brief report statis the financial challenges and impact of COVID-19 over the past 8 months. Plans to address the finances and a budget going forward are mentioned below.

• 08.2 2018 Audit

This audit was submitted to GAISF. IJRU is incorporated in the US, and the US doesn't require annual audit. A "review" (a mini audit) can be conducted when necessary. IJRU's finances are in accordance with financial accounting regulations in the US.

08.3 Current Financial Position

This document current is of August 31, 2020 and states the present value in the IJRU bank account. There are no major pending debts. IJRU needs considerably more funds to appropriately run and advance the organization and sport.

08.4 2021 Forecast Budget – Approval

This document shows where most of IJRU's expenses lie. As many expenses as possible have been cut from the budget in order to keep the organization in as strong of a position as possible.

Motion: It has been proposed to approve the 2021 IJRU Forecasted Budget.

09. Constitution and Policy

09.1 Constitution Amendments – Approval

The Constitution as approved in Norway in 2019 and the Constitution changes document have been available for review for 60 days, along with a color-coded version reflecting the changes. Some changes were minor, such as grammar updates, and others more drastic, such as procedure amendments. Feedback on changes to the Constitution was received from four persons/NGBs.

Motion: It has been proposed to approve the amendments of the IJRU Constitution - sections C1,2,3,4,5,6,8,9,10,11,12,14,15,17,18,20,21,23,24,25,27 for minor variation to spelling, grammar and readability.



Discussion: The IJRU Constitution was made based on extracting the best aspects of the FISAC-IRSF and WJRF Constitutions, as well as input from other International Federations. In the future, NGBs will also be consulted to seek and gain feedback.

Outcome: Carried

Motion: It has been proposed to approve the amendments of the IJRU Constitution - sections C7,13,16,19,22,26, which are changes as reflected in the IJRU Control Document referencing variation to the existing Constitution.

Discussion: None **Outcome:** Carried

09.2 Youth Development Commission Charter – Approval

This has been available for review on the IJRU website. International organizations must have a strategy and plan for youth, so this document is essential for IJRU.

Motion: It has been proposed to approve the IJRU Youth Development Commission Charter.

09.3 Athlete Council Document Suite – <u>Approval</u>

IJRU received much guidance from GAISF and other international federations on this topic. The Athlete's Council is essential for IJRU to move forward. The Athlete Council Document suite involves the following two documents, which have been available for review on the IJRU website.

09.3.1 Athlete Council Charter

09.3.2 Athlete Council Election Procedure

Motion: It has been proposed to approve the Athletes Council Document suite.

Discussion: It is mandatory that the athletes on the council speak English in order to communicate with IJRU, etc. The possibility of an interpreter can be looked into. An extra six athletes are indicated to allow for keeping a balance of gender and continental representation, etc. The age requirement is 18-years old, as complex issues are addressed warranting an athlete of such age or older. Athletes on the IJRU Board do not represent their country, but the sport as a whole. They do not have voting rights at a General Congress, as with the other Board Members.

Outcome: Carried

09.4 Ethics Panel Document Suite – <u>Approval</u>

The following four documents constitute the Ethic Panel Document Suite, which have been posted on the IJRU website for review. All of the documents are in accordance with the IJRU Constitution and each other and ensure IJRU runs in a fair and ethical manner.

Motion: It has been proposed to approve the Ethics Panel Document suite.

Discussion: The difference between "conduct" and "ethics" is as follows: "Conduct" is what is approved conduct by IJRU, and "ethics" are standards for behavior. Anonymous complaints will be followed up on, but at certain stage information will need to be shared in order to process such a complaint. The issue of confidentiality is addressed in the documents. The Safe Sport Strategy and Education will be reviewed by the relevant committee.

Outcome: Carried



09.5 Financial Committee Charter – Approval

This document has been posted on the IJRU website for review. The main objective is to help the IJRU Board fulfil its responsibilities regarding finances.

Motion: It has been proposed to approve the Financial Committee Charter.

09.6 Gender Eligibility Policy Update – <u>Approval</u>

This policy was approved in the July 2019 General Congress, but since then changes were necessary. The updated version has been posted on the IJRU website for review. The two main changes were altering the names of the championships and clarifying the age requirement language.

Motion: It has been proposed to approve the Gender Eligibility Policy.

Discussion: The changes were made to ensure the policy reflects the content of the IJRU Constitution and so that the policy is in line with the IOC Policy.

IJRU needs at least 40 full members to meet the membership criteria in GAISF. In 2019 IJRU's initial membership in GAISF was 7.5% when 3 countries were added as full members. In 2020 IJRU broadened its membership by the recognition of 17 new full members, for a 42.5% increase. To date IJRU has reached 50% of the minimal requirement of 40 countries with 20 full members. IJRU wants to reach this goal by 2022. IJRU hopes to move all NGBs up in status to full membership level, and for each NGB to successfully maintain that status.

12. Technical Congress

12.1 2020 Technical Congress Update

There are 25 countries that have submitted Congress delegates. The first meeting was held virtually on May 31, 2020. Seven proposals were voted upon and approved regarding the IJRU rules at that time.

Motion: It has been proposed to ratify the 2021 Judging and Competition Handbooks.

• 12.3 Virtual Competition Proposal

IJRU is planning to hold a virtual world championship in 2021 due to the impact of COVID-19. IJRU is asking the General Congress to allow the Technical Committee and Technical Congress to proceed with the implementation of this. The virtual championship will enable more athletes to be able to participate. Its structure will be similar to that intended for the 2021 Ottawa, Canada World Championships. There will be a preliminary event which will be completely prerecorded, and final event which will be livestream, even though the athlete's competition videos themselves will not be live. Video quality will be important. Detailed information will be presented when available.

Motion: It has been proposed to approve the delegation of authority to the Technical Committee and the Technical Congress to proceed with the structure and implementation of a Virtual World Championship for 2021.

Discussion: Based on IJRU's analysis of the world situation, most countries will not be able to travel internationally in 2021. IJRU cannot handle such a loss financially to plan and downscale or cancel an onsite event. Thus, the IJRU Board is proposing to go virtual. As for the competition month, July is the goal, as that is when the onsite competition would have been. Competition videos will need to be submitted well in advance to allow for judging. The judging method will be very specifically outlined so that judging is consistent and fair to all athletes.

Outcome: Carried

Note 1: IJRU is not going to publicly announce about the virtual competition decision on this time, but rather let the NGBs have the opportunity to inform their athletes, coaches, judges, and other stakeholders first. On October 24 IJRU will inform the NGBs of the rules to pass on to their athletes. On November 2 general information will be communicated to the public. IJRU is not giving up on live competitions and will try to incorporate them as best as possible in the future.

Note 2: Continental championships are up in the air at the moment due to COVID-19, as the future is very hard to predict. The board will discuss about this issue, as IJRU's job is to always do what is best for the athletes.
