- IJRU received an appeal from Czech Rope Skipping Association (CRSA) requesting a review of the decision NOT to grant CRSA National Governing Body (NGB) status in IJRU. IJRU BOD's made the decision to award NGB status to Czech Jump Rope, (CJR) in December 2019 whereas this was confirmed by the IJRU General Congress in October 2020.
- Both organisations provided a three (3) minute address the IJRU Congress. The Czech Rope Skipping Association, (CRSA) representative, Jana Černá addressed the Congress for 3 minutes followed by Czech Jump Rope, (CJR) represented by Martina Varkočková President.

Motion: Seek IJRU Members decision to either accept or deny the appeal lodged by CRSA in relation to not granting NGB status to CRSA in October 2020.

Discussion: If the appeal is accepted, that will not revoke CJR as the present member, but rather the BOD will have a meeting and invite both CRSA and CJR to speak and then proceed as deemed necessary. If the appeal is not accepted, CJR will be responsible for allowing all Czech jumpers the ability to participate in CJR activities.

Outcome: Carried (Yes - Deny the appeal lodged by CRSA in relation to the IJRU BOD's existing decision to not grant NGB status to CRSA)

• 12.7 The Court of Arbitration of Sport (CAS)

On October 20, 2021, the Court of Arbitration of Sport (CAS) upheld IJRU's decision for the National Governing Body Representation for Hong Kong, China Athlete 1 & Hong Kong Rope Skipping Federation, China v. International Jump Rope Union.

• 12.7 World Anti-Doping Agency (WADA)

- On December 17, 2020, the Court of Arbitration for Sport (CAS) rendered its decision in the case between World Anti-Doping Agency (WADA) v. Russian National Anti-Doping Agency (RUSADA) (CAS 2020/O/6689). In this decision, the CAS Panel determined RUSADA to be non-compliant with the World Anti- Doping Code (THE CODE), and as a result, issued several orders which came into effect on December 17, 2020, for a period of two (2) years (expiry December 16, 2022).
- On October 7, 2021, the World Anti-Doping Agency (WADA) issued an all-stakeholder communication confirming that the National Anti-Doping Organizations (NADOs) of the following countries were declared non-compliant with the World Anti-Doping Code (Code) with immediate effect: Democratic People's Republic of Korea; Indonesia; and Thailand
