B. 2022 year in review for AJRU

This past year continued to be a challenging time for everyone due to COVID-19, but the AJRU board worked hard, meeting regularly every month via Skype to move the sport forward in Asia.

Major accomplishments of AJRU this past year include finalization of the official registration of AJRU in Hong Kong, China and subsequent recognition by IJRU as the official continental organization of Asia. AJRU now also has an official website up and running (www.ajru.sport), as well as official e-mail addresses for each board member. In addition, registration for the first ever virtual AJRU Asian Championship is complete, with video submission and judging upcoming, and the results to be released by the end of the year. The board also spent time progressing the following topics: AJRU Technical Committee activities, future online workshop planning, AJRU social media promotion, and Asian coaching course planning and development.

AJRU continues to be in close contact with IJRU regarding the membership status of countries in Asia and is hoping that its official recognition will provide more opportunities to reach out to new countries in Asia to encourage them to join IJRU and AJRU.
