More than 900 participants were there, and the 2024AC was title sponsored by 361 Degrees, a famous sports brand manufacturer from China. The 2024AC was livestreamed on YouTube and China's CCTV social media, so it was broadly spread. Many new Asian records were created in this event. AJRU obtained a lot of experience from this event and made the milestone for jump rope sports being title sponsored by international sports brand.

- Opening greeting from AJRU President & confirmation of attendees (Michael Chan & Janet Locke)
- President Michael gave a greeting and welcomed everyone. This is the first on site General Assembly AJRU has held.
- A quorum was established.

2. Approval of the minutes of the previous Ordinary General Assembly (Janet Locke)

3. Address from IJRU (Shaun Hamilton)

- Refer to attached document.
- AJRU was congratulated on its successful championships and General Assembly. For the first time in history of the sport of jump rope, three international high level events have been held consecutively (WC2023, EC2024, AC2024) using the same scoring system. IJRU will continue to use that system to help standardize the competition format, and allow the performance of both judges and athletes to be tracked.
- Refer to the market survey QRL code in the attachment to provide very useful feedback to further enhance the sport.
- The Olympics organization has changed. GAISF has dissolved, and now AIMS is the new entrance point to the Olympics. IJRU is still an observer with AIMS. There are new criteria for membership: 5 years of existence and 3 years of existence.
- Refer to the overview of the IJRU strategic plan. Efforts are being made regarding sponsorship, holding conferences and camps for professional development of our sport, the event approval process, athlete ranking, solidarity, streaming, etc.
- Even larger numbers of participants are anticipated for the 2025 World Championships in Kawasaki, Japan in July 2025, with even more coverage and opportunities. IJRU continues to exist for the sport and for the athletes.

4. President's report (Michael Chan)

- The AC2024 is the "report" to everyone. Thanks to JJRU, the COC members, and all of the NGBs for all of their hard work to make the AC2024 a success.
- In 2024, there were monthly board meetings, as well as COC meetings. After difficulties with banking policies and regulations, this year AJRU was finally able to set up the AJRU bank



account in Hong Kong, China and can now create the financial infrastructure of AJRU.

- AJRU was able to have a title sponsor for the AC2024, 361 Degrees, and will continue to look for other sponsors, not only for the Asian Championships, but for workshops and other opportunities. AJRU is also making an effort in the realm of social media.
- In regards to judge issues, CRSA (Chinese Rope Skipping Association) intends to prepare a budget to pay all expenses for people who will be serving solely as judges for the AC2026 in China.
- AJRU wants to help provide technical support for judges and coaches, as well as provide assistance in regards to the management of NGBs which would like assistance.
- AJRU has provisional recognition from the OCA (Olympic Council of Asia), but at present only 13 member countries/regions, so it still has room to grow in order to incorporate all 48 countries/regions in Asia. AJRU will work together with IJRU to encourage more Asian NGBs to join IJRU and AJRU.
- In 2025 in Uzbekistan the Asian Youth Games will be held, and AJRU is hoping to have a jump rope performance show take place there. AJRU will continue to encourage Asian NGBs to work together.

7. Appointment of an auditor recommended by the Board of Directors (Michael Chan)

• An annual audit is requested by the Hong Kong, China government. After the AC2024, the bank account will be activated and the money from ARSF (former Asian Rope Skipping Federation) that is presently being held by IJRU, as well as income from the AC2024 and title sponsor 361 Degrees will be transferred to the new AJRU bank account. Then the audit consultant service AJRU is enlisting assistance from, "Good Faith," will do an annual audit.

8. 2024 Asian Championships report & official appreciation of JJRU (Michael Chan)

 The Asian Championships just ended yesterday, so a report is not available yet. JJRU was thanked for their efforts to make the AC2024 a success.

9. 2026 Asian Championships (Michael Chan)

 Huaibei City is in the middle of China, near Shanghai. Buses will shuttle people to the competition venue. The local government will provide sponsorship support, and AJRU is already looking forward to another successful championship.



10. Future strategy and plans for AJRU (Michael Chan)

- AJRU needs to create more revenue to support the sport and athletes. AJRU is continuing to look for sponsors. AJRU is authorizing all of the Asian NGBs to look for sponsors, and AJRU will also help to coordinate between NGBs to find sponsors to recommend potential sponsors to other NGBs, thus creating a sponsorship network.
- Another financial infrastructure item is judge and coach licenses. AJRU is planning on holding workshops, possibly with the first one being in Southeast Asia, followed by one in Middle Asia.
- In regards to the OCA, AJRU is communicating with them about the possibility of a jump rope show at the Asian Games in Uzbekistan next year.
