
The European Rope Skipping Championships 2026 will take place in August in the Oslofjord Convention Center, Norway.



### B. Year in Review

# 1. Provide an overview of the types and numbers of competitive events held during this period

2023: 5<sup>th</sup> ERSO Show Contest, 25.11.2023, Zeist/The Netherlands, with 13 teams from 6 countries 3<sup>rd</sup> ERSO Wheel Contest, 26.11.2023, Zeist/The Netherlands, with 13 couples from 5 countries. The contest was in a battle style with double elimination system.







2024: The European Rope Skipping Championships event, combining the 22<sup>nd</sup> European Team Championships with the 15<sup>th</sup> European Individual Championships, was held from 14.-20.07.2024 in Eger/Hungary. In total 641 athletes from 12 countries competed in the European Open Tournament, the Junior European Championships and the European Championships. For the first time, the event also included the Double Dutch Contest Europe.



### 2. Discuss major accomplishments/ programs /events/ highlights for the past year,

The EC 2024 had the highest participation ever in the long history of European Championships. Also, the ERSO working group was growing compared to 2022. With the incredible work of the host in Hungary, we can say that the EC 2024 has reached another level in the appearance and also the flow of the competition days. Even with technical problems due to thunderstorms etc., we managed to end every competition day in time.


#### 3. Going forward, discuss your biggest concerns for your Confederation.

Once again, we have detected problems in the current judging system, leaving behind frustrated athletes (not being awarded correctly for their routines) and judges (knowing that they did their best, that wasn't enough).

We sincerely hope that the current changes lead to a direction that awards the right athletes and allows the judges to judge correctly and feeling comfortable in judging.

In addition, we suggest to publish changes in the judging system including offering the respective judges courses a minimum one year before the next WC, in order to allow the NGB's to adapt to the changes and conduct their WC qualifiers under the rules that will be used during the WC.

#### 4. In memoriam Richard Stannard



With a heavy heart we had to inform the community that the former ERSO president and honorary ERSO member Richard Stannard passed away very suddenly and without prior indications just a week before the EC 2024.

His innovational drive and knowledge had an immense influence on the digitalisation and visualisation of the sport how we know it today. He served as President of the ERSO from 2011 until 2019. We would like to honour again what he did for the Rope Skipping / Jump Rope community.

### 1. Welcome and voting instructions

Sebastien welcomed all participants of the AGM. Further, he explained the voting structure of this year's AGM.

### 2. Roll call

Nicolai went through the list of attendants (see annex 1). Representatives that are marked with a \* were registered but not present during the meeting. Additionally, some guests were attending the AGM. The ERSO board welcomed Shaun Hamilton, the president of the International Jump Rope Union, lana Belonoschenko, the president of Israel Jump Rope, and invited Ingo Reinhardt (GER) and Gerhard Blümel (AUT) as potential auditors.

### 3. President's welcome

Silke welcomed everybody to the AGM. She mentioned that there are some votes for today. ERSO is excited for the Finals within the next two days. She planned to keep the meeting as short as possible.

## 4. Welcoming words from the International Jump Rope Union

Shaun Hamilton welcomed everybody with a warm welcome. He expressed his condolences of the passing of Richard Stannard and highlighted the work that Richard has done to advance the sport in Europe and the World.

Shaun was impressed by the running European Rope Skipping Championships and expressed his thanks to all the volunteers and organisers of the event as they are doing a tremendous job.

Shaun asked to fill in the market survey of the IJRU since the feedback from the NGBs is necessary to provide an accurate number and representation of the sport for potential sponsors.

He informed that there is a new landscape within the organisation of Olympic recognized sports . GAISF, the former olympic recognition association is dissolved. AIMS is the new organisation with new criteria of Rope Skipping/Jump Rope, and other sports, to be recognized as a sport.

Additionally, IJRU is updating their strategic plan for 2025 to 2030 with some new goals and aims.

The world championships in 2025 will be held in Kawasaki, Japan, tentative dates are July 27th - August 3rd.



### 5. Approval of the Agenda

The Agenda, which was sent out with the invitation link, was slightly updated due to the unexpected passing of Richard Stannard. It was voted on the approval of the changed agenda.

## 7. Annual reports

#### President's report

The 2024 European Rope Skipping Championships had approximately 640 athletes attending. In comparison, in 2022 there were 727 participants registered including all judges, officials, coaches and supporters. Having a growing sport, more volunteers and helping hands are appreciated for future events.

Silke thanked all the volunteers that are working at the 2024 European Rope Skipping Championships. Silke asked the NGBS to contact their members if there are talented people that like to engage and are willing to help out with organising future events.

With Nicolai stepping down from the Board of Directors, ERSO has two vacant spots on the board. We hope we can fill them in the near future.

#### Treasurer's report

Sebastien showed the balance and cash flow of the 2023/2024 fiscal year. A summary of the treasurer's report is in the appendix. ERSO is using an online booking system for the cash flow of all competitions and expanses. Sebatien raised concerns that some invoices were not paid fast enough, some NGBs



only paid their expanses shortly before or on the beginning of the event. Luckily, ERSO had enough funds to prepay most of the expenses, however, this might not hold true for future events.

## 9. Membership

The ERSO board accepted Israel Jump Rope as an observational member. Iana Belonoschenko, the president of Israel Jump Rope, was present in the meeting. In sport Israel is considered to be included in European competitions even though geographically Israel is part of Asia.



#### Israel Jump Rope:

lana Belonoschenko introduced herself and the work they do to structure, organise and grow the sport in Israel. During the discussion, Belgium representatives asked for additional information from Iana based on the political situation in the country and her personal background in Russia. Iana explained that she moved to Israel after the war in Ukraine started. Before, she has been a representative of the Russian organisation but no longer belongs to that organisation and fully represents Israel Jump Rope.

Sebastien mentioned that during discussing the membership of Israel Jump Rope the Board of Directors also had a discussion about criteria for organisations to become a member. In the past, ERSO had some countries that were approved, but neither worked on growing the sport in their country nor paid membership fees. ERSO is planning to determine clear criteria for potential members.

## 13. European Rope Skipping Championships 2026

Silke presented the potential host of the 2026 European Rope Skipping Championships, the Oslofjord Convention Center in Norway. It is located 100 km south of Oslo. The planned dates would be at the end of June/beginning of July. There might also be an option to have the event in August.

The representatives of Greece, who have participated in the 2024 European Cheerleading Championships, stated that they had a great time in Oslofjord during the competition and they can imagine that the venue would fit perfectly for Rope Skipping/Jump Rope.

In a brief discussion, it was stated that smaller NGBs might be interested in hosting the event but holding off since the general organisation is too much for too few volunteers. For bigger delegations a solution without accommodation would mean a lot of additional work.

Several countries expressed concerns about the proposed date for the EC at the end of June/beginning of July. They noted that this timing falls outside of school holidays, which would make it difficult for some athletes to attend. On the other hand, the option in August is the first week after the Summer



holidays in some Nordic countries and therefore having EC 2026 in August is not optimal as well. ERSO will try to book the venue for the second week in August.

### 14. ERSO Show Contest - Future

It is planned to have the next Show Contest in 2025. ERSO will organise a meeting discussing the future of the Show Contest in fall. The invitation will be sent out via email to the NGBs.

### 15. Any other information

No other topics were discussed during the AGM.

## 16. Adjournment

Silke thanked the representatives for their time and their participation in the hybrid AGM.

### Introduction

This report summarises the finances of the European Rope Skipping Organisation (ERSO) for the year ending 30 June 2024. As a non-profit organisation run by volunteers, ERSO is committed to have a healthy financial management to support its events and athletes.

This year saw two major events – the Show Contest 2023 and the European Championships 2024. To streamline hotel package payments for the Championships, ERSO implemented a new consolidation account. This account received incoming payments and facilitated transparent management.

A portion of these funds was promptly forwarded to the Hungarian Rope Skipping Federation (MUKSZ) to cover immediate costs. The remaining balance will be transferred in the next fiscal year.

All in all, the ERSO closes a healthy account for another year.

## **Explanation of Statement of Activities**

### Core activities

We define "core activities" as activities that match our mission statement. These activities are currently: European Championships, Show- and Wheel Contest and educational (i.e. judging and coaching).

#### **Membership fees**

Revenue generated is allocated towards covering operational and general costs. Operational expenses include bank fees, IT and internet services, website maintenance, and others. Additionally, funds support general expenses such as marketing, branding initiatives, and necessary meetings.

### **Event consolidation**

The ERSO worked together with MUKSZ (Hungarian federation) to organise the European Championships of 2024. To help our members, we decided that payment goes completely through the ERSO account and not the account of MUKSZ as well. However, that results in receiving money that is not supposed to be on our account. Hence the consolidation. A transparent account to show what revenue is intended for ERSO and MUKSZ.

As is shown, we still owe MUKSZ €316.708,00. This is also reflected in our balance sheet. The ERSO is paying this amount in the next fiscal year.
