05. President's Address – "TOGETHER"

• The President's Address "TOGETHER," was given by Shaun Hamilton, President of IJRU. The president talked about several objectives focusing on how working together we can achieve more and move the sport forward. Over the past summer there were successful Asian and European Championships, where records were broken in such areas as attendance, visibility, as jump rope records. Furthermore, the sport was represented at the Paris 2024 Olympics with activation activities given by professional athletes from multiple IJRU countries. The prior year, IJRU had a huge success with the 2023 World Championships in Colorado Springs, Colorado, USA, and footage is still being shown on various prestigious broadcasts reaching the world. There are new AIMS statutes which IJRU needs to satisfy to maintain its observer status and move forward. IJRU is now partnering with the International Workers & Amateurs Sports Confederation (CIST) and the International School Sports Federation (ISF). IJRU will be completing an MOU with the ISF in Bahrain. IJRU has developed an Event Approval Process to enable the sport to further evolve worldwide. A call to action was made to encourage all NGBs to proactively take part in various initiatives that IJRU is pursuing.

6.1.1 Italy, FIDESM – Federazione Italiana Danza Sportiva e Sport Musicali (Italian Dance and Music Sports Federation)

Motion: In accordance with the IJRU Constitution and with the recommendation of the IJRU Board of Directors, it has been proposed that the Italian Dance and Music Sports Federation, FIDESM, who are recognized by CONI, Italian National Olympic Committee, (Comitato Olimpico Nazionale Italiano), be confirmed as IJRUs recognized NGB in Italy at the provisional level.

06.1.2 New Zealand

Motion: In accordance with the IJRU Constitution and upon the recommendation of the IJRU Board of Directors, it has been proposed that Skipping New Zealand be confirmed as IJRU's recognized NGB for New Zealand at the provisional level.

06.2 New Observer Status

06.2.1 Mexico

Motion: In accordance with the IJRU Constitution and upon the recommendation of the IJRU Board of Directors, it has been proposed that the Mexican Association of Rope Jumping Activities A.C., be confirmed as IJRUs recognized NGB for Mexico at the observer level.

06.2.3 Pakistan, Pakistan Jump Rope & Rope Skipping Federation

Motion: In accordance with the IJRU Constitution and upon the recommendation of the IJRU Board of Directors, it has been proposed that Pakistan Jump Rope & Rope Skipping Federation be confirmed as IJRUs recognized NGB for Pakistan at the observer level.

06.3 Situations where sanctions are in place

06.3.1 Russia

Russia was suspended from membership in IJRU in 2022, in accordance with the IOC's recommendation. IJRU met with the president of the association to understand their present situation, and the decision was made to seek support from the NGBs to permit athletes to participate in the 2024 IJRU World Championships. This requires a change to be made to the IJRU Constitution to enable a new membership category.

Motion: The IJRU General Congress agrees with the intent of creating an amended category within the IJRU Constitution to add a new membership category.

Discussion: Clarification was given as to the reason why this type of action is necessary in this situation and how this is not just a change for Russia, but any country/region in such circumstances in the future.

Outcome: Carried (17 yes, 3 no, 5 abstain) (1did not vote)
